The Mauritius Cane Industry Authority, set up by the Mauritius Cane Industry Authority Act No 40 of 2011, is a parastatal body operating under the aegis of the Ministry of Agro-Industry and Food Security.

Applications are invited from suitably qualified candidates for the following positions:

1. **IT Manager (Ref: ITMAN/017)**
2. **Air Monitoring Officer (Ref: AMO/017)**

Post 1: IT Manager (Ref: ITMAN/017)

Qualifications:

A degree in Computer Science or Computer Engineering or Information Systems or Information Technology or any degree, the major part of which should be Computer Science or Computer Engineering or Information Systems or Information Technology, from a recognized Institution or an equivalent qualification acceptable to the Board.

Candidates should also:

- (i) possess good communication, interpersonal and organising skills;
- (ii) have the ability to exercise initiative and sound judgment;
- (iii) have strong commitment and leadership qualities; and
- (iv) have a track record of having led a team of IT personnel.

Salary Scale: Rs 26300 x 775 – 32500 x 925 – 37125 x 1225 – 40800 x 1525 – 49950 x 1625 – 62950

Main Duties:

The IT Manager will, *inter alia*, be responsible for all works relating to Information Technology, including coordination and management of projects, preparation, updating and implementation of IT Plans, preparation and appraisal of tenders for hardware, software, etc. and establishment of software and data security procedures to protect the confidentiality of information at the Authority.

Post 2: Air Monitoring Officer (Ref: AMO/017)

Qualifications:

Candidates should possess a degree in Environment or Health or Science related field from a recognised institution or equivalent qualification acceptable to the Board;

Candidates should also:

- (a) reckon at least 3 years' experience in laboratory or scientific related duties;
- (b) have a knowledge of processing activities and air cleaning technologies;
- (c) have technical skills in troubleshooting and repairs of electronic analytical instruments;
- (d) have leadership, organisational and good interpersonal skills.

Main Duties:

The Air monitoring Officer will, *inter alia*, be required to carry out test for the purpose of monitoring quality of air emission. He/She will have to climb stacks, normally up to a height of 50 metres, in the performance of his/her duties.

Candidates should have reached their **18th** birthday and, unless already in the ^{Local}Public Service Government Service/Approved Service, should not have reached their **45th** birthday by the closing of submission of applications.
